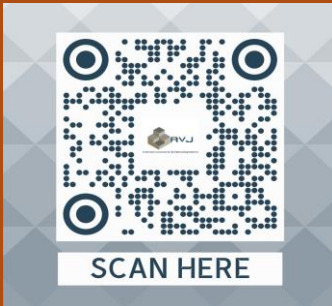

AVJ CONSTRUCTIONS & DEVELOPMENT is affiliated with a consortium operating in the UK, Greece, Cyprus, UAE, and Morocco.

AVJ CONSTRUCTIONS & DEVELOPMENT will be capable of offering distributor services and facilitating direct sales from the factory to prospective investors.

OFFICIAL SELLER AGREEMENT (this "Agreement") is made and entered into as of 20 June 2024 ("Effective Date") between DAS SOLAR CO., LTD. with its registered office at 43 South Bailing Road, Quzhou City, Zhejiang Province, 324022 P.R. China and AVJ CONSTRUCTIONS & DEVELOPMENT DOO, a company organized under the laws of SERBIA REPUBLIC, (with its registered office at Tosin Bunar Novi Beograd , Serbia, PIB 109940086 , MB 21271187) ("OFFICIAL SELLER"), which are collectively referred to as the "**Parties**" and individually referred to as a "**Party**".

WHEREAS:

- A. DAS is in the business of developing, manufacturing, and selling PV modules throughout the world; and agrees to appoint an OFFICIAL SELLER as its authorized distributor to sell the Products (as defined below) in, SEBRIA, BiH, MONTENEGRO (Country);
- B. OFFICIAL SELLER is in the business of distribution of PV modules and wishes to sell and promote certain DAS PV modules, ("Products") in Serbia, BiH, and Montenegro.
- C. DAS wishes to appoint an OFFICIAL SELLER as its non-exclusive distributor to sell and promote the above-mentioned products in Serbia, BiH, and Montenegro.

NOW THEREFORE, on the principle of mutual benefit and through friendly negotiations, both Parties as a result of this agree as follows:

1. Object and Purpose

1.1 Subject to the terms and conditions of this Agreement, DAS hereby appoints OFFICIAL SELLER as its authorized distributor to sell and promote the Products in the Territory (as defined below), and OFFICIAL SELLER hereby accepts such appointment and agrees to sell the Products in the Territory.

1.2 OFFICIAL SELLER shall purchase DAS-Branded Products from DAS in its name and for its account and shall sell them to third parties in its name and for its account.

2. Territory

2.1 OFFICIAL SELLER is allowed and obligated to promote and sell the Products to customers located in Serbia, BiH, Montenegro, ("Territory").

2.2 OFFICIAL SELLER shall not: i) engage in any promotional activities relating to the Products directed primarily to customers outside the Territory, ii) solicit orders for Products from any prospective customer located outside the Territory, or iii) solicit orders for Products from any prospective customer located in the Territory with a view to their exportation.
